**NOTICE OF APPEAL**

PLEASE TAKE NOTICE that the Appellants, Tremaine Golson a/k/a Tremaine D. Golson and Brittney L. Golson a/k/a Brittney L. Greene, hereby appeal to the South Carolina Court of Appeals from the Order entered on June 5, 2025, by the Honorable Milton G. Kimpson in the Court of Common Pleas for Richland County.

This appeal is taken from the Court's denial of Appellants' Motion to Correct Clerical Error pursuant to Rule 60(a), SCRPC, as well as the imposed bond requirement outlined in the Order dated May 7, 2025, reaffirmed and enforced by the June 5, 2025 Order.

Grounds for Appeal include, but are not limited to:

1. The trial court erred in finding no clerical error in the Final Order, despite a misidentification of parties which creates ambiguity for enforcement and compliance.
2. The imposed bond requirement of \$74,056.00 total (\$37,028.00 per bond) constitutes an excessive financial burden in violation of the Eighth Amendment to the U.S. Constitution and Article I, § 15 of the South Carolina Constitution.

3. The trial court's refusal to stay execution without bond, despite evidence of hardship, constitutes an abuse of discretion and denial of meaningful appellate access.

Appellants respectfully preserve their right to full appellate review of all related orders and enforcement measures stemming from the May 7 and June 5, 2025 Orders.

This Notice is submitted without a Motion to Proceed In Forma Pauperis. No financial affidavit is included.
