I ask the South Carolina Supreme Court for permission to file a supplemental Brief. My car was never in JPD custody to perform an inventory search.

Mr Hubbard or Ms Fuller which left the jury to believe what wasn't true yet Mr Hubbard said he wasn't forthright
