
**APPELLANTS' MOTION TO WITHDRAW APPEAL**

Under Rule 260 (c) SCACR, the Appellants Patricia E. Lane, Kevin J. Lane, Timothy J. Lane, and Matthew W. Lane (collectively "Appellants ") hereby request the Court to withdraw their appeal originally filed on April 19,2024. The grounds of said request for withdrawal of its appeal are as follows:

1. The Beaufort County Master-In-Equity issued his Amended Final Order in this matter on March 12, 2024.
2. A Notice of Appeal was filed by the Respondent Robert M. Lane on or about April 15, 2022.
3. Appellants filed its Notice of Cross Appeal on or about April 19, 2024.

4. That on September 3, 2024 this Court dismissed the appeal filed by the Respondent Robert M. Lane.
5. That Appellants have elected to no longer pursue their cross-appeal and wish to dismiss same.
6. That on May 21, 2025 counsel for Appellants requested from the Respondent Robert M. Lane his consent to the withdrawal of their appeal pursuant to Rule 260(b) SCACR. ( Ex. 1) . No response was received.


