NOTICE OF INTENT TO PETITION FOR WRIT OF CERTIORARI


PLEASE TAKE NOTICE that the Appellant, **Randal K. Freeman**, appearing pro se, hereby gives notice pursuant to **Rule 242(c), South Carolina Appellate Court Rules (SCACR)**, of his intent to petition the **South Carolina Supreme Court** for a **Writ of Certiorari** to review the Order of the South Carolina Court of Appeals dated **June 6, 2025**, which denied Appellant's Petition for Rehearing of the Court's March 20, 2025 Order dismissing the appeal as moot.

This notice is timely filed within the 15-day window required by Rule 242(c), SCACR. Appellant asserts that the Court of Appeals' ruling involves substantial questions of law and constitutional concerns, including unresolved due process violations and the doctrine


