Dear Honorable Patricia C. Grant, Clerk of Court:

I, Albert Edward Siders, am requesting respectfully all legal documents pertaining to two Court Orders requested by two Court Judges whom directed the South Carolina State Attorney General's Office to produce proof of the original records of all legal documents to my complete case file.

On the date of November 6, 2019 the Honorable Jude Brookes Goldsmith, and also on the date of February 24, 2021, the Honorable Judge Hood did in fact direct and order the South Carolina State Attorney General's Office to produce proof and show cause that the State should uphold my conviction by the video evidence of the robbery showing the pointing of the BB gun and proof of the Chain of Custody to authenticate the video evidence as an original record to my PCR case file.

The reason why these two PCR Court Judges did in fact order the South Carolina State Attorney General's Office to produce the proof of authenticating the video evidence of the robbery showing the pointing of the BB gun to my case file is due to the fact that my trial transcript is a part of my case file, and according to the

original trial transcript recorded on April 21, 2015, my conviction was solely based on and deliberated on testimony and video evidence of the robbery being committed by the pointing of the BB gun and also described by the (State Prosecutor Steve H. Knight) and the State's leading witness (Jurnell Washington) how the alleged robbery was being committed by the pointing of the BB gun.

Because of the corruption that has taken place before, during, and after trial by the misconduct of court officials, I am sending copies of this requested letter humbly and respectfully to the Court of Appeals, to the Appellate Judges and to the Court of Administration in order to prevent any delays and to expose transparency that I am open and honest and in fact seek to be clearly understood as to what I am seeking from your Office of the Clerk of Court.

Therefore, the State Attorney General's Office of South Carolina has failed to comply with both Court Orders, and on the date of November 27, 2023, the State Attorney General's Office of South Carolina conducted a PCR hearing, failing to comply to show cause to the PCR Court Judge Roger Young the video evidence in which the State Prosecutor introduced to the Court and jury by the pointing of the BB gun in which I was convicted.

Therefore with this important request, I respectfully ask the Honorable Clerk of Court to send me copies of the two Court Orders that were requested, Clock Stamped and Filed by which the Honorable Judge Goldsmith dated on November 6, 2019 and the Court Order requested by the Honorable Judge Hood dated on February 24, 2021, directing and ordering the South Carolina State Attorney General's Office to produce proof by authenticating original records to my complete case file.

In conclusion, I am respectfully asking the Honorable Patricia C. Grant Clerk of Court to include, but not limit to, an authenticated affidavit report from Video Expert of Mr. Watkins, and most importantly I am requesting the document to the chain of custody pertaining to the video evidence introduced at my trial on April 21, 2015 by the displaying and showing by the pointing of the BB gun.
