Tomeka,

I have added your transcript to my list to produce. I know you will need the transcript for your appeal, but it's my understanding the time to produce is longer than the 10-day deadline. The production of the transcript takes a significant amount of time, typically 30 to 60 days, and an expedited transcript for the hearing held on March 26<sup>th</sup> would be in the ballpark of \$800, while a non-expedited transcript would be in the \$300 range.

I don't want you to incur unnecessary costs, and I am limited in my time to produce it within a two-day deadline.

I just wanted to let you know my thoughts, but I've got you added to my list and will get started soon.
