NOTICE OF APPEAL

Pursuant to South Carolina Appellate Court Rule 203(b)(1), Appellants The Settlement, LLC and Levi Grantham, LLC (“Appellants”), by and through the undersigned attorneys, hereby appeal the Order of Circuit Court Judge William C. McMaster, III dated June 16, 2025, which (1) denies The Settlement, LLC and Levi Grantham, LLC’s Motion to Vacate, or in the Alternative, Modify or Correct Arbitration Award, (2) grants Icon Custom Masonry, Inc.’s Motion to Confirm Arbitration Award, and (3) orders judgment in favor of Icon Custom Masonry, Inc. against Defendants The Settlement, LLC and Levi Grantham, LLC (“Order”).
