

The Defendant/Appellant, Michael C. Whitlock, Jr., hereby gives notice of his intent to appeal to the South Carolina Court of Appeals from the convictions following his jury trial held on May 21, 2024, through May 24, 2024, and sentencing in this case (Indictment Numbers 2023GS1003220-3222), and from the order denying Defendant's timely-filed motion for a new trial.

The sentencing orders imposing judgment upon the jury verdicts and sentencing Mr. Whitlock to 35 years in prison for murder and attempted murder, along with a five-year sentence consecutive to that term, were entered by the Honorable Bentley Price, Circuit Court Judge, on May 24, 2024, and the order denying Defendant's timely-filed motion for a new trial was entered by the Hon. Roger M. Young, Jr., on June 9, 2025.




