## ORDER

---

On May 22, 2025, this court temporarily granted Appellant a stay, remanded to the circuit court, and directed the circuit court to hold an expedited hearing on Appellant's motion to stay and determine the amount of an appeal bond. The circuit court held a hearing, and in an order filed June 16, 2025, set the appeal bond as follows: "Appellant must pay a back dated bond in the amount of \$9,100 within 5 days of this order and make monthly payments of \$700 thereafter."

On June 18, 2025, Appellant filed an emergency motion to modify stay conditions, seeking this court to modify the conditions of the stay to permit installment payments of the back-dated bond and to extend the time for compliance with the bond condition. After careful consideration, we deny Appellant's emergency motion to modify stay conditions.
