

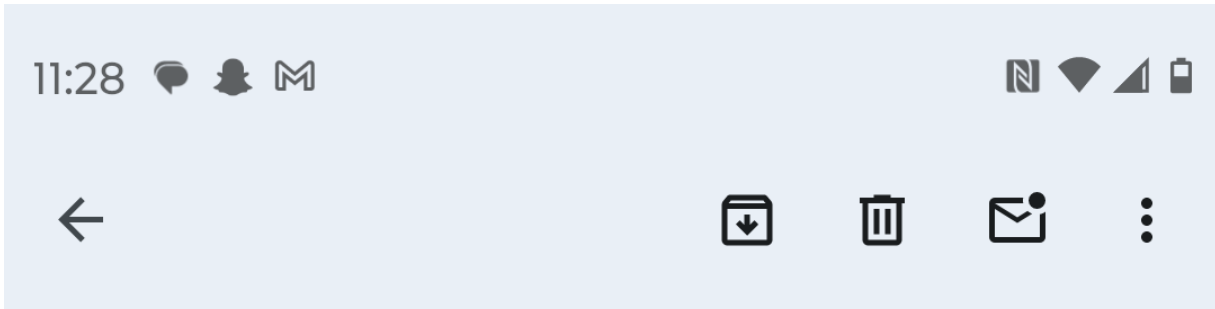

My name is Barney Wimberly and I writing this letter to asking the courts to please to please have my property sign back over to me. I worked over half of my life to pay for this property so I will have a home when the time came I couldn't work anymore are I retired. Then someone is trying to take it that's been in our family life 18 months. She has only been on this property 3 to 4 times and those times she never gotten out the vehicle. She didn't pay one dime to help bury my brother. They wasn't even together when he passed away they wasn't even together when he passed away he kicked her out too much earlier because of her stealing and opening credit cards in his name. She couldn't help with the funeral but yet since she passed away she has purchased several new cars purchase a brand new home put in a \$7,000 well three or four thousand dollars on a sewer system and don't even work and got breast implants . This property should have been signed over to me the first of the year in January 21 when the probate attorney came by the house. He came to the house give me another guy on the front porch I spoke with him I told him at that time I paid for the

property in full I had a receipt he said no problem that day he wasn't doing anything that he was just going around looking at all the properties and he said to give me to give him my information and he would contact me the following week following week came and left second week came and left so I called his office respond young lady in the office name is Diane she said she would have him call me back in the last 4 years I have called him numerous times to get this taken care of even yet to call me back we went to court December 23rd 2023 and Summerville Troy Knight courthouse. When the judge said we go break for recess while she makes her decision when the bailiff came out there and said come on back in the probate attorney and Raymond Hames attorney did not show back up they left the judge was upset then quote her she said they didn't come back because they knew what the outcome was going to be in favor of me I don't understand at that moment why the property didn't get signed over to me I don't have a lawyer I'm not a lawyer I don't know but I don't understand why the probate attorney is favoring the other side I thought he was supposed to be a mediocre person in the middle I would have won the case I feel in St George in from March get the judge said if she would have seen the receipt. I was down with my legs and I couldn't make it they told me I could sit in a letter which I did through email I asked the probate Thomas kilpatrick did if I need to send the receipt he said you don't need to send anything because she'll have everything she'll pull up everything from the Summerville trial. Now I know that's a lie. If I would have said that in like I wanted to but I was thinking not knowing that the probate wasn't favored either side I know now that's not true. I'm begging you to get my property signed back over to me because if I lose it I have nothing I can't go back to work if there's a chance I'm going to lose both of my legs the doctor said because I have not been able to do my treatments because they cut the power off and I cannot run my treatment machines I had to get rushed to the ER Friday a week ago. I don't understand how the course can give something to somebody that came then this family with nothing just a shirt on her back and want to sit here and take everything get new cars breast implants a new home she didn't have a home now she wants to take mine it's not fair and I'm throwing myself in the mercy of course but please don't let this happen the last thing my brother told me he said bubba if something happens to me investigate and then I said what do you mean she said she is trying to kill me and she probably will all I'm saying is investigate. The property was in my name I originally bought it early 90s around 92. I'm going to attach the email one of the time they told me that I didn't stand a chance with Joe the field of court because I was not a lawyer and I wasn't LLC dog wasting my time and they even told the deputy that orchester county and he's the one that told me that my mom. Then I was speaking with the sheriff on the phone and I handed your deputy the phone and he told the sheriff the same thing. If that's true I think that is unreal and that's not fair because I'm not an LLC I'm not an attorney I'm sorry I can't afford one I'm not asking for anything else my brother had I'm just asking for the property that I purchase in the 90s and owned. I know you're trying to figure out how it got in my brother's name down below I will try to explain how. I've been disabled the past five and a half years with no income. I've been fighting trying not to lose my legs the doctors cannot figure out what's going on with them. I'm more less bedridden but I can walk about 25 steps to 30 steps to go to the restroom. But everyday gets harder and harder. The day after I applied for the appeals I got a message from the lawyers that is representing the other party. Again I apologize for the misspelled words and not the correct punctuation . I was told by the lawyers representing the other side that I didn't stand a chance and appeals court because I was not a lawyer and I was not LLC all right I got told this twice by them one of them to email and I will attach the email to this letter. The property that we're talking about I purchased at 92 with my wife at the time. When we purchase the property it was just raw property that had trees bushes weeds everything you can think of foreign raw property goes. Everything that I cleared off

I'd done my head myself I dug and removed 28 trees on his property by myself I landscape the property planted every blade of grass. My wife of 25 years left in 2012 with house. Payment/property payment. It was hard for me to keep up. With all the bills she left me with but I did. I tried to get her to sign divorce papers but she wouldn't. I didn't owe but very little on the property. Robert and I was very close and we did everything together. Hunted, fish and got in the Shriners together. My mom and dad got a divorce when he was infant and coming up I was like a father figure to him. We were very tight. Well in 2016 I knew that the minute I pd the home and property off. My. Ex would want half the value of the place. So my brother and I came up with a plan to let the place go in foreclosure and he would purchase it. So I did that and we went to courthouse when it went up for sale and he purchased it. Several yrs later she sign divorce papers. My brother call me on August the 12th 2020 to wish me a happy birthday. And he would be over the 14th for the cookout. I told him that I wa going pay him the balance on property then He came over and I pd him the balance and he said let me write you a receipt and he ask me if it would be ok if we sign the paperwork over the 1st of the year. Then it would be starting a new tax year. I said no problem that would be fine with me. But sadly say he didn't make it 50 years old he passed away a couple months later November 20 20. Again I'm sorry that it's not worded correct are the punctuation or not correct I'm sorry I'm just in a lot of pain try to get this done get up to myself at the University of court please don't take my home it's one place I got to live I work my whole life for this and I paid it off everything you see on this property I done or I pd someone to have. Please help me get my property sign back over to me. I'm already losing it worry about the next Dr visit to have them say they going to have take my legs. I lose my property and then my legs. I just as well give up on life. Because I be homeless. I'm not saying that's what going happen the next Dr visit. I pray not. But the Drs warn me at the last visit. If they gotten worse because I can't use my treatment machines. Because They cut my lights off. They are going have to make some kind of decision. All of this is killing my mom she has a pacemaker and all this is destroying her knowing her that girl Courtney is trying to take all this where got my brother's other several properties new homes and everything cars. Some throw myself in the nursing court please God I'm begging you with all my life with this I watch my girls had their first birthday parties graduation parties this is not a normal piece of property that I just purchase somewhere I took woods that made it until a home front. Thank you for your time and God bless each and every one of you. I'm going attach photo of a screen shot where lawyers saying I was not going get anything out of appeal court. Don't quote me the exact words you'll see what I mean when you read the email. Also I'm attaching a picture of my legs show I'm not making that up. Like the lawyers told someone Top photo is my treatment machine thank you. S/Barney Wimberly
