RESPONDENT'S FINAL BRIEF


I, Rebecca S. Williams, attorney of record for the South Carolina Criminal Justice Academy (Respondent), respectfully request, pursuant to Rule 240 of the South Carolina Appellate Court Rules, this Court amend the record on appeal.

The record on appeal does not comply with Rule 210.

Specifically, Appellant has provided the Record on Appeal provided by Respondent to the Administrative Law Court in the initial appeal instead of the specific items listed in the parties' Designation of the Matter. The current Record on Appeal includes items not included in the Designation of the Matter and fails to include Appellant's brief to the ALC, ALC order dated July 16, 2024, or ALC Order dated August 23, 2024. Appellant did not include what they described as Complaint and Answer, but Respondent argues it should not have been included in Appellant's

Designation of the Matter because it was not presented to the Administrative Law Court and was not a part of that appeal. Finally, the Record on Appeal does not comply with the required order pursuant to Rule 210(c).

Because the Record on Appeal does not comply with Rule 210, Respondent is unable to complete Respondent's Final Brief as required by Rule 211. Respondent requests an extension of it's deadline until twenty days following the service of the Amended Record on Appeal.


