OPPOSITION TO PETITION TO DISMISS APPEAL

Appellant Terry Clark respectfully submits this Opposition to the Petition to Dismiss filed by Respondent. This Opposition is filed in good faith to preserve Appellant's rights to due process and to protect the legal and constitutional integrity of this matter.

Respondent's request to dismiss the appeal, the motion for restoration of possession, and the petition for damages related to property loss is premature and unjust. The underlying appeal raises critical issues stemming from the improper and premature execution of a Writ of Ejectment on June 12, 2025. Appellant and her minor child suffered significant harm, including the loss of over \$7,000 in personal belongings, due to the mishandling and exposure of her property during the court-ordered eviction.

Despite numerous emergency filings seeking temporary stay and restoration relief, the Court of Appeals has not rendered a ruling. This failure to address the Appellant's motions has caused irreparable harm. Moreover, the pending Supreme Court Petition filed under Rule 245, SCACR, seeks not only a stay of enforcement but also an order compelling the Court of Appeals to issue a decision.

This matter is not moot. Substantial relief is still being sought, including damages for property loss, recognition of the procedural mishandling, and the opportunity for equitable redress. To grant dismissal solely on the Respondent's request, without hearing the merits of the Appellant's claims, would violate principles of fairness and due process.

WHEREFORE, Appellant respectfully requests that this Honorable Court deny the Respondent's Petition to Dismiss and proceed to review the merits of the pending appeal and associated motions.
