The attached orders granting the motions for costs filed by Respondent City of Beaufort (including the City of Beaufort Historic Review Board) and Respondent Beaufort Inn LLC only address the costs assessed against Appellant Historic Beaufort Foundation. This is a consolidated appeal involving two separate circuit court matters, one filed by Appellant Historic Beaufort Foundation and one filed by Appellants West Street Farms, LLC and Mix Farms, LLC. For this reason, in their motions for costs, the Respondents also requested the assessment of attorney's fees totaling \$2,500 against Appellants West Street Farms, LLC and Mix Farms, LLC, for a total award of \$5,000 to Respondent City of Beaufort (including the City of Beaufort Historic Review Board) and a total award of \$5,000 to Respondent Beaufort Inn. Is the Court issuing a separate order addressing the request for attorney's fees against Respondents West Street Farms, LLC and Mix Farms, LLC?
