Good morning, All,

Please accept this correspondence as providing an update on the transcript request and response to the June 10, 2025 letter. As you know, the transcripts for the entire trial and post-trial motion hearing were requested on April 9, 2025 (the request previously was filed with the Court). Subsequently, after several inquiries/follow-ups via telephone and electronic communication to Court Administration, the Parties received notice/update of the reassignment of the requests to a new transcriptionist on April 24, 2025 (attached). Based on my discussions, it is my understanding that the original Court reporter/transcriptionist was no longer available and could not complete the transcripts. On May 14, 2025, Velvet Mills, Transcript Manager for Legal Eagle, contacted Defense Counsel with an estimate of costs for the trial transcript. Defense Counsel inquired with Ms. Mills and Court Administration about the post-trial motion's hearing transcript status (attached). Subsequently, the post-trial motion's hearing transcript was assigned to Legal Eagle on May 28, 2025. That same day, Defense Counsel provided confirmation to pay the estimated costs of the transcripts, and the transcripts were sent to production with a sixty-day production deadline (July 28, 2025). Defense Counsel has not received any other updates/information regarding the transcripts.
