The Court of appeal Dismissed the appeal based on the Record of appeal Not being filed Proper, When I asked for Clarification & time to Process the information but they refuse to Acknowledge any Evidence I submitted because I am representing myself Pro Se

Since the Court of appeal won't acknowledge the new Evidence Submitted of the Inadmissible evidence, Brady Violations & Conflict of Interest.

The New Chief of Hanahan Police (Rick Gebhardt) Gave me the information that the Attorneys was Hiding all these years so I just Now received Enough evidence to take this case to trail this is a open & shut case because the Chief is willing to testify that the City been took the former officer badge for the gross negligence that not only cost me 366 days but an innocent 9 years old black child her life I seek (Justice For All black Lives)

The City of Hanahan & Berkeley County has been Harassing & arresting Black people for years but they never have to pay because the Judges Work together in South Carolina

I have submitted proof of me being insane but because They feel no attorney will take my Case, they will continue to take advantage of me.

The City of Hanahan is well Known For their KKK affiliation for years because of my amended Brief They fired Everyone including their old Chief in order to Cover Up all the officer's gross negligence, I am experiencing severe trauma because The South Carolina Courts Want me to believe Black lives Don't matter if we are Mentally disabled.

The statute of limitations is suspended based on the ADA Rule but The Courts don't care about following the ADA rules because they believe I won't be able to afford to take this to trial.

I am being Discriminated against based on my lack of legal compacity
Hopefully I will not need to involve (Black lives matter)
But unfortunately, the South has not changed

The state Would rather collect the money off Black Men who are falsely arrested & the Courts are more focused on collecting our Court fees.

I require Mental health treatment Charleston County Doctors at mental health Would testify that people like me end Up becoming serial killers.

The South Carolina Court Would Rather Give me a trail for Murder than a Civil trial for My false arrest they like for black Men to kill our Black women but My friends in Law enforcement taught me never to take the law in my own hands!

My Mother Crystal Wilson & My Sister Hillary wright who was 9 years Old was brutally Murdered by a Man who suffers from Mental health issues like me so I understand What the Courts & the City of Hanahan won't acknowledge.
