I think it's evident: my codefendant's out-of-court statement(s) were used to assert truth(s), was not prior subject to cross-examination, nor present at trial. I was never allowed to confront my accuser. My trial attorney objected to this, it was ruled upon by the judge, thus, I feel, it is preserved and ripe for review on Direct Appeal.


Consider TT-159:20-25, 160:1-12 Perhaps you overlooked this. It is Det. Gebings' testimony. Then you have Det. Beusse on the stand: TT-462:2-15 (where the judge clearly states [Lines 14-15] "You can't say what someone else told you, okay?")

Yet that is clearly abused by the judge, solicitor, and Det. Beusse — 465:7-25, 466:1-17 (where he now contradicts and overrules). Now look at 496:9-16 (Scott on cross.) Then again back to Huey/Redirect TT-499:25, 500:1-25, 501:1-25, 502:1-25, 503:1-25, 504:1-25 and 505:1

When read, and the law applied, I believe the judge abused his discretion, it's a meritorious Direct Appeal issue, and you should raise it and give the Court a chance to rule on it/remedy it.

Write me back and let me know your assessment of this after you read the above references to parts within my Jan. '12 Trial Transcript.


