from South Carolina Court of Appeals this morning regarding letters that I have received from them regarding a Motion to Stay request submitted to the courts. One of the deficiencies was that she had not provided a proof for service. Latasha has a signed statement that was submitted to the court verifying that she had served me notification. That is not true. I did not receive anything in writing from her. In addition, I was not notified by the courts of a hearing that was scheduled on June 5th, that Latausha appeared over an hour late for. When I spoke to a representative at your office. I was told that I was not notified because there was not an address or phone number on file for me. I had been told that the hearing would be scheduled for July 10,2025. That was

confirmed by Dorothy Belton. I spoke with her and was trying to see if there was a way that I could be scheduled before the 7/10/25 She told me there was not. I was really surprised when I found out that the hearing had taken place without me being notified. The set out date began on monday 6/20/25. Because the belongings Were not removed from the home 48 hours from Monday, Latasha was given additional days until today to have her property removed from the residence. She does not reside in the residence and has not resided there since, 2019. The home has been vacant for over the past 4 years while we have been in and out of court. There is A bunch of belongings piled up on the deck of the home. Furniture is in the yard. I have people scheduled to start repairs tomorrow. I was ordered to leave the home on yesterday until further notice. I am requesting that that motion to stay be set aside, because Latasha has not been honest and she has not served me. Her sworn statement verifying service is not true. The home needs a lot of repairs and I have people scheduled to start coming in tomorrow. This has been like an emotional stressful roller coaster for me. Please ask the judge if he will set aside the motion. I am the home owner and Latasha continues to lie to the courts and provide fraudulent false documentation. Therefore this request is made.
