MOTION TO FILE NEWLY FORMATTED AMENDED RECORD ON APPEAL
(Pursuant to Rule 240, SCACR)

COMES NOW, Terry Lennette Grant, respectfully submits this motion to file the newly formatted Amended Record on Appeal.

1. Appellant previously filed an Amended Record on Appeal in this matter on June 20, 2025 which consisted of a condensed format, from (4) four Volumes to (3) three Volumes. Appellant was told that a motion must be filed to make these kinds of changes.
2. Upon further review, and several deficiency notices, Appellant has reformatted and corrected the Record on Appeal to ensure full compliance with the requirements of Rules 208, 209, and 240, SCACR, including but not limited to:
 - Consistent pagination;
 - Proper referencing and citation to the Appendix;
 - Correction of formatting inconsistencies;
 - Inclusion of all required documents in chronological order with proper indexing; and was reformatted to the original (4) four volumes.
3. Appellant seeks to file the amended Record on Appeal in the interest of justice, clarity, and judicial efficiency, to aid the Court in its review and to avoid any prejudice to the Respondent or to the Court's process.
4. This Motion is made in good faith and not for the purpose of delay. Appellant believes that allowing the newly formatted amended Record on Appeal will better facilitate the appellate review process.
5. Respondent will not be prejudiced by the granting of this Motion, and no substantive changes have been made to the content of the Record—only formatting and organizational corrections.
6. Respondent also submitted a motion to supplement Record on Appeal to include pages 1105-1139. Appellant included the Respondent's supplement to the newly formatted Record on Appeal as Volume IV.

WHEREFORE, Appellant respectfully requests that this Court issue an Order:

- Granting leave to file the newly formatted Amended Record on Appeal;
- Accepting the newly submitted Amended Record on Appeal as timely filed nunc pro tunc to the original filing date given on June 25, 2025; and
- Granting such other and further relief as this Court deems just and proper.
