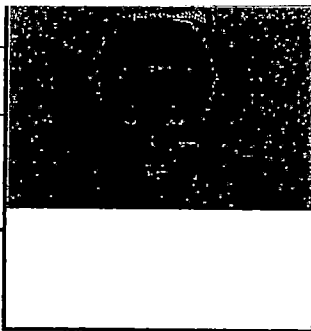

DESCRIPTION OF OFFENSE: 16-03-0010, 16-03-0020 / MURDER

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

ON THURSDAY 09/12/2019, THE AFFIANT RESPONDED TO 207 W LUCAS ST (TIGER MART), IN THE CITY OF FLORENCE, IN REFERENCE TO A MURDER. THE AFFIANT OBSERVED THE VICTIM LYING ON THE GROUND AFTER HE HAD BEEN SHOT SEVERAL TIMES. THE AFFIANT SPOKE WITH A WITNESS WHO STATED THAT THE DEFENDANT (WHO GOES BY THE NAME "MAN MAN") AND UNKNOWN CO-DEFENDANT WERE THE SUBJECTS THAT SHOT THE VICTIM. THE WITNESS WAS WITH THE VICTIM AT THE TIME OF THE INCIDENT JUST PRIOR TO THE SHOOTING AND WAS PHYSICALLY ASSAULTED BY THE DEFENDANT JUST MOMENTS BEFORE THE VICTIM WAS SHOT. THE VICTIM WAS OBSERVED ON VIDEO TRYING TO MOVE AWAY FROM THE DEFENDANT JUST BEFORE GETTING SHOT AND FALLING IN THE ROADWAY. THE VICTIM MANAGED TO MOVE TO THE SOUTH WEST CORNER OF THE BUSINESS BEFORE THE DEFENDANT AND UNKNOWN CO-DEFENDANT SHOT THE VICTIM MULTIPLE TIMES AT CLOSE PROXIMITY ABOUT THE HEAD AND BODY.




