Respondent’s Motion to Hold Final Brief Deadline in Abeyance

Respondent Newberry College (“Respondent”) requests that the court hold Respondent’s deadline to file its final brief in abeyance until Appellant Abdellah El Farissi (“Appellant”) files and the court rules on Appellant’s Motion to Supplement the Record on Appeal because Appellant failed to include material designated by Respondent in the record on appeal in this matter.

Respondent filed its initial brief and designation of matter on March 7, 2025, in compliance with Rule 209 of the South Carolina Appellate Court Rules. (*See* Respondent’s Designation of Matter filed Mar. 7, 2025). The South Carolina Appellate Court Rules require Appellant to include all material designated by Respondent in the record. *See* Rule 210(c), SCACR (“The Record on Appeal shall include all matter designated to be included by any party under Rule 209 . . .”). Appellant filed a record on appeal that does not include an item listed in Respondent’s designation.

(Compare Respondent's Designation of Matter filed March 7, 2025, with Record on Appeal filed June 11, 2025).

Appellant attempted to remedy this omission by filing Appellant's Supplement to the Record on Appeal on June 26, 2025. However, on June 30, 2025, Appellant was informed by the court that he must file a motion pursuant to South Carolina Appellate Court Rule 240 to supplement the record on appeal. The current deadline for Respondent to file its final brief is July 1, 2025. However, Respondent cannot finalize and submit its final brief until the record on appeal is supplemented with the missing material identified in Respondent's designation.

Accordingly, Respondent requests the court hold the deadline to submit its final brief in abeyance until Appellant has filed and the court has ruled on Appellant's Motion to Supplement the Record on Appeal.
