**APPELLANT'S MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S
INITIAL BRIEF**

Appellant South Carolina Department of Insurance hereby respectfully moves, with consent of counsel for Respondents, pursuant to Rules 240 and 263 of the South Carolina Appellate Court Rules¹ for an Order granting Respondents a thirty (30) day extension of time to file their initial brief in response to Appellant's Initial Brief filed with the South Carolina Court of Appeals, on the following grounds:

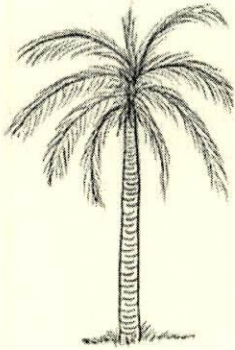
