Respondents Michael A. Maucher, Esq., and DeLuca & Maucher, LLP, submit this cross appeal pursuant to Rule 203(c), SCACR, of the following orders:

1. Judge van Slambrook’s Order denying Defendants’ Motion to Strike, dated November 6, 2024. **See Exhibit A.**
2. Judge van Slambrook’s Order denying Defendants’ Motion to Reconsider the Order denying the Motion to Strike, dated January 30, 2025. **See Exhibit B.**
3. Judge Salvini’s Order denying Defendants’ Motion for Sanctions, dated June 18, 2025. **See Exhibit C.**

Appellant filed its Notice of Appeal on June 27, 2025. Appellant’s Notice of Appeal was filed prior to the 10-day time expiring for Respondents to ask for reconsideration of the June 18, 2025 Order denying sanctions. Respondents asked the circuit court to reconsider its order denying


