**PETITIONER’S MOTION FOR EXTENSION
OF TIME TO FILE PETITION FOR
WRIT OF CERTIORARI**

The Petitioner Treasurer for Marlboro County respectfully moves this Court for an Order granting a thirty-day extension of time to file and serve a Petition for Writ of Certiorari and Appendix up to an including August 13, 2025 in the above referenced action as discussed below.

The Petitioner’s Petition for Rehearing was denied by the South Carolina Court of Appeals on June 12, 2025, and accordingly, the Petition for Writ of Certiorari and Appendix are currently due to be filed by July 14, 2025.

While this matter was still pending in the Court of Appeals, the Defendants Ronald D. Kirby, Dylan T. Kirby, and Danny T. Williams reached a settlement with the Respondent RS&A Piping & Fabrication, Inc. a/k/a R. S. & A Piping, Inc. In their filing withdrawing the Petition for Rehearing filed by the Defendants Ronald D. Kirby, Dylan T. Kirby, and Danny T. Williams, it was represented that “the Appellants have agreed to dismiss, with prejudice, the underlying action to set aside the tax sale deed and personal conversion.” To date, no such stipulation of dismissal has been filed. Counsel for the Petitioner attempted to obtain the parties’ consent to a stipulation of dismissal to that effect and to get that filed before the current deadline, but they have been unsuccessful. Counsel for the Respondent has advised that he is waiting on his client and that he will need additional time to confirm whether he can enter into a stipulation of dismissal ending this case with prejudice.

Given these circumstances, the Petitioner does not wish to waive any of his rights including the ability to seek a writ of certiorari in this Court should the Respondent not agree to the dismissal of the action against all Defendants with prejudice. As reflected in his Petition for Rehearing, the Petitioner believes that there are valid and meritorious issues for this Court to review on certiorari and that the Court of Appeals’ reversal and remand was in error. This request for an extension is not submitted for purposes of delay but rather to protect the Petitioner’s rights if this action is ultimately not dismissed with prejudice by the Respondent, as currently expected that it will be.

WHEREFORE, the Petitioner Treasurer for Marlboro County respectfully requests that it be granted a thirty-day extension of time to file and serve a Petition for Writ of Certiorari and Appendix up to an including August 13, 2025.
