On 02/14/2025 the Appellant filed: "Interrogatories Questions to Defendants, D.R Horton" and "To Release the List of the D.R Horton Witness" in this case.

D.R. Horton reply: On 03/14/2025 By the Denial and Reject to Release the List of DRH Witness in this, Will send a copy of the Interrogatories Questions and on 04/07/2025 the Plaintiff (Appellant) filed a Motion to Investigate against D R Horton and Dorchester County on fraudulent and attempting to harm the Plaintiff (Appellant) will send a copy of the Motion and Exhibits

On 06/16/2025 the Plaintiff (Appellant) did file Motion to Strike:

1) Chris Hill and Kelsey Harper Affidavits D.R. Horton Memorandum to the Opposition to the Plaintiff Motion for Injection and the Motion to Strike The Dorchester County Lawyer Bradley Mitchell.

Will send a copy of the Motion to Strike, on 06/18/2025 D.R. Horton submitted their Memorandum in Opposition to the Plaintiffs Motion to Compel: Discovery Responses:

Just a half an hour before the virtual hearing on 06/18/2025 at 10am.

D. R Horton never served the Plaintiffs, just emailed 5 minutes before the hearing. All of this has been recorded on the court website, "SC Judicial Branch" and also, Dorchester County submitted its Answer to D R Horton Counterclaim on 06/17/2025, just one day before the hearing on 06/18/2025 at 10am 8 months after the 30-day deadline, from or since D R Horton filed the Counterclaim against the Plaintiff and Dorchester County on 10/11/2024.

Technically Dorchester County lost the lawsuit against D R Horton by Default Judgement.

The Judge Matie Murphy did not do anything for those violations mentioned.

This is why: the chief Honorable Judge Diane Goodstein take over and removed Judge Murphy from the case. and she stepped in the replace her. That is why Judge Matie Muphy denied the Plaintiffs Motion of Reconsideration to the Plaintiffs Motion to the Injunction, before she left the case, even before she heard the other Motion or Pending Motion like, Motion to Strike Chris Hill and Kelsey Harper Affidavits and D R Horton Memorandum and Dorchester County Lawyer Bradley Mitchell even before she heard the Motion to Compel, D.R. Horton to Answer the Plaintiffs Interrogatories Question or Produce Documents.

So Judge Goodstein found out that:

Judge Murphy was very prejudice to the County and D R Horton favoring them, to the point she Judge Goodstein set up a date for the Trial on 06/23/2025, even before the ADR -Mediation. Which should have been on 07/24/2025 and she called both Mark Bible and Bradley Mitchell to be at the trial on 06/23/2025 and she also put the trial as a top priority case on the courts list of cases.

Due to the violation and corruption from Dorchester County and D R Horton and the Plaintiff believed that Judge Matie Murphy was involved in those Violations. We will email a copy of the trial and ADR date, to confirm these facts.
