

Dear Honorable Court,

In response to the Court's Order that was rendered on April 23, 2025 declining to rule on the Appellant's **MOTION TO RECONSIDER**, pursuant to Rule 221(c) SCACR; the Appellant begs the court's pardon due to the record reflecting that his filings were within the (15) FIFTEEN Day requisite time period.

On March 20, 2025 the Court pronounced the initial Order to deny the Appellant's **MOTION TO PROCEED IN FORMA PAUPERIS**, and after receiving it on March 24, 2025, the Appellant submitted to the court his **MOTION TO RECONSIDER** on April 2, 2025 by placing it in the U.S. Mail.


The Appellant concedes that he is Pro Se and Indigent, as he seeks clarity on the above captioned issue as well as the following:
