

Jeremy David Larkin appeals his conviction and sentence in this case. The sentence was sealed by the Honorable R. Scott Sprouse, Jr., on March 7, 2023. The sentenced was imposed by Honorable Jessica Salvini on July 8th, 2025. Defendant was tried in his absence after a motion for continuance was denied, thereby depriving defendant of due process of law. Additionally, defendant's motion to suppress the body-worn camera video should have been granted because there was no probable cause for the search of the motor vehicle and the video was used to improperly bolster the testimony of the State's witness.






