MOTION FOR AN EXTENSION TO SERVE AND FILE  
THE PETITION FOR WRIT OF CERTIORARI  
AND APPENDIX

Counsel for David Eric Hugue respectfully requests a **final thirty (30) day extension, from August 1, 2025 until September 2, 2025** in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for David Eric Hugue respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Brief of Petitioner in the case of The State v. Terry G. Gridine with the Supreme Court on July 24, 2025. Counsel filed the Petition for Rehearing in the case of The State v. Harold G. White, III with the Court of Appeals on July 17, 2025. Counsel filed the *Johnson* Petition for Writ of Certiorari and Appendix in the case of Travis Jessup v. State with the Supreme Court on July 14, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Marcus C. White with the Court of Appeals on July 9, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Terrance Wing with the Court of Appeals on June 26, 2025. Counsel filed the Brief of Petitioner in the case of Keylan J. Durham v. State with the Court of Appeals on June 20, 2025.

4. Counsel makes this request in good faith and not for purpose of delay.

5. On July 29, 2025, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through August 30, 2025.


