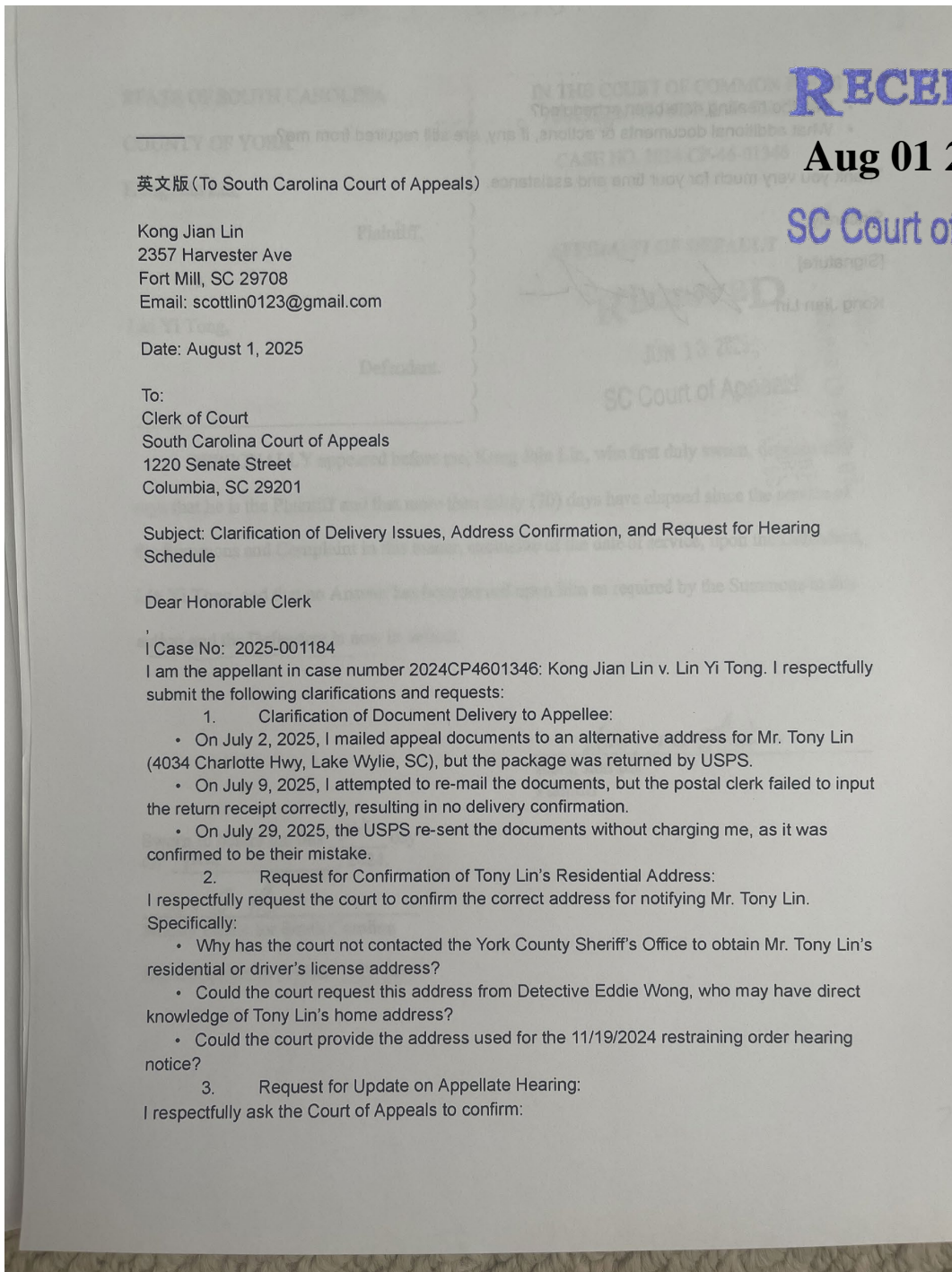



1. Clarification of Document Delivery to Appellee

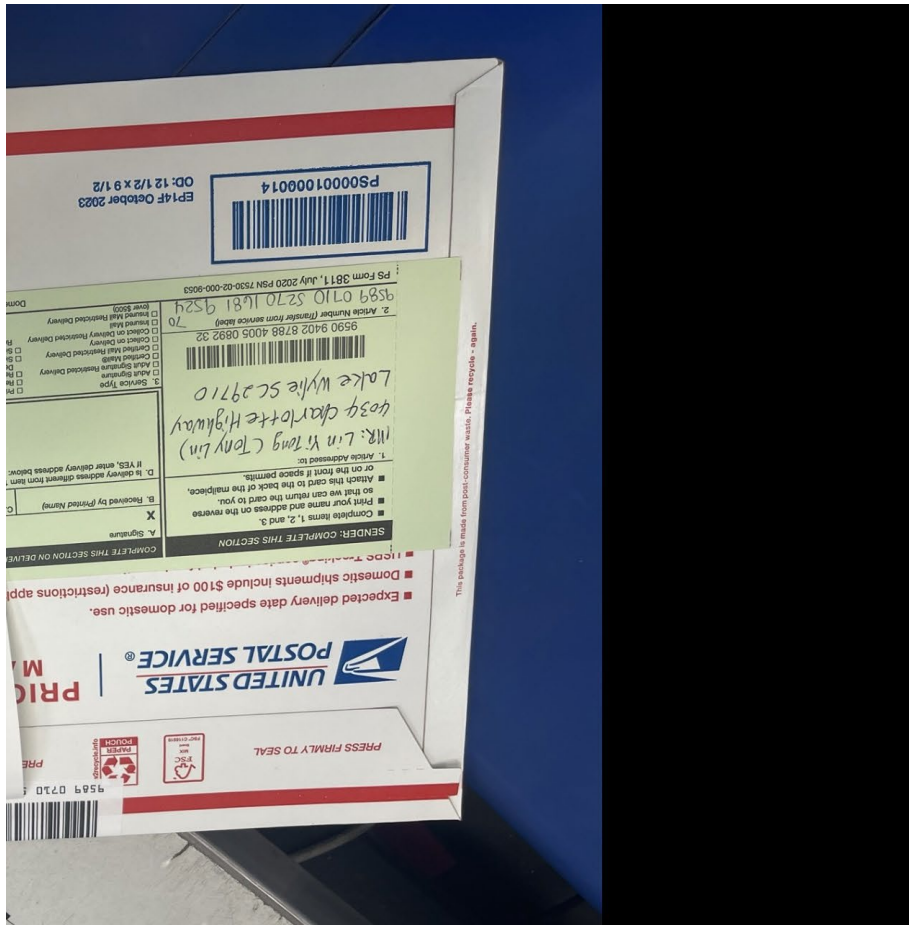
