**MOTION FOR EXTENSION OF TIME TO FILE RESPONDENT’S INITIAL BRIEF  
AND DESIGNATION OF MATTER TO BE INCLUDED IN RECORD ON APPEAL**

Pursuant to South Carolina Appellate Court Rules 208(a)(2), 209(a), 240, and 263, the respondent, City of Anderson, South Carolina (the “City”), moves for a thirty (30) day extension of time in which to file and serve Respondent’s Initial Brief and Designation of Matter to be Included in the Record on Appeal in the above-captioned matter. This is the first request for an extension of time by the City. The initial brief and designation are currently due August 13, 2025. The extension, if granted, would extend the deadline to September 12, 2025.
