Dear Mr. Reilly:



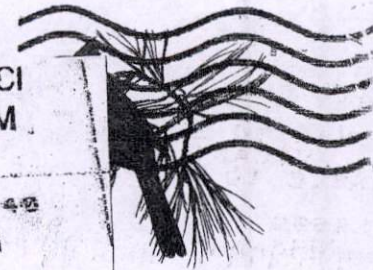
