THIRTY-DAY STATUS UPDATE AND REQUEST FOR EXTENSION

Pursuant to the Court's directive for periodic status updates regarding the proceedings in the lower court, Appellants Tremaine D. Golson and Brittney L. Greene respectfully submit the following:

1. Lower Court Order on Supersedeas Bond: On August 6, 2025, the Richland County Court of Common Pleas entered an order denying Appellants' Motion to Lower the Supersedeas Bond.
2. Original Bond Order: The bond requirement was originally set by order of the lower court dated July 15, 2025.
3. Requirement of Bond for Stay: As a result of the August 6, 2025 denial, the lower court has required that the supersedeas bond be posted in the originally ordered amount for the stay of execution to remain in effect.
4. Lower Court Proceedings on the Merits: The lower court has indicated that it will proceed on the merits of the case while the appellate process is pending, absent the posting of the bond.
5. Appellants' Position: Appellants maintain their position that the ordered bond amount is excessive and not proportionate to the circumstances of the case. Efforts to comply with procedural requirements are ongoing, and further appellate relief may be sought as appropriate.

REQUEST FOR EXTENSION

In light of the lower court's recent ruling and the financial implications of the ordered bond, Appellants respectfully request an extension of the deadline for any further required appellate filings or actions related to the stay, to allow adequate time to address the bond requirement and preserve their rights on appeal.
