Good morning, everyone. Previously Judge Kimpson presided over an additional hearing requested by the S.C. Court of Appeals regarding the appeal bond in this matter. Judge Kimpson issued his order on July 15, 2025, and I have attached a copy of that Order with this email.

I have also attached a copy of the August 6, 2025 Order from the S.C. Court of Appeals regarding this matter. The first page of the Order deals with matters in the appellate case. The last page of the Order is in regard to the state court portion of the case. The Court of Appeals has denied the Defendants/Appellants motion to reduce the amount of the bond set by Judge Kimpson in his order of July 15, 2025. The bond set by Judge Kimpson was for a bond with two sureties in the amount of \$18,514.00 and was due within 15 days of the July 15 date of the Order. Now that the Court of Appeals has denied the motion to reduce the bond, I believe the Defendants/Appellants must post the bond with the Clerk of Court within 15 days of the date of the August 6, 2025 Order of the Court of Appeals in Order to keep the vehicle that is the subject of this case pending the appeal.

I wanted to make sure that the Court was advised of the decision by the Court of Appeals.
