AMENDED NOTICE OF APPEAL

John Kachmarsky, individually, as Manager of K&T Group, LLC, and as Trustee of the Revocable Trust of John Kachmarsky dated November 30, 2007, as member of K&T Group, LLC, by and through his undersigned counsel, hereby files this Amended Notice of Appeal.

On July 11, 2025, Appellant filed a Notice of Appeal from the Order Granting Motion to Reconsider entered on June 17, 2025, which granted Defendants' Motion to Reconsider the Court's April 24, 2025 Form 4 Order. As stated in that Notice, it was filed out of an abundance of caution while the Court was considering Plaintiff's Motion for Reconsideration of the November 26, 2024 Order. Plaintiff's Motion for Reconsideration has now been denied by Form 4 Order entered August 1, 2025.

Accordingly, Appellant now appeals from the following Orders:

1. Order entered on November 26, 2024 by the Honorable Mikell R. Scarborough, Master in Equity for Charleston County, granting Defendants' counterclaim and dismissing Plaintiff's claims with prejudice;
2. Form 4 Order entered on August 1, 2025 by the Honorable Mikell R. Scarborough, Master in Equity for Charleston County, denying Plaintiff's Rule 59(e) Motion to Reconsider; and
3. Order Granting Motion to Reconsider entered on June 17, 2025 by the Honorable Mikell R. Scarborough, Master in Equity for Charleston County, granting Defendants' Rule 59(e), SCRCF Motion to Reconsider and reinstating the Court's original Order of November 26, 2024 (This Order was appealed in Appellant's original Notice of Appeal filed July 11, 2025).

Counsel for Appellant received written notice of entry of the November 26, 2024 Order on November 26, 2024; the June 17, 2025 Order on June 17, 2025; and the August 1, 2025 Order on August 1, 2025. Copies of all Orders on appeal are attached to this Amended Notice of Appeal.
