MOTION TO EXCEED PAGE LIMIT

1. The default page limit for briefs. under Rule 208(b)(1), SCACR, is 50 pages unless otherwise ordered by the Court.

3. The amended brief consolidates and streamlines Appellant's arguments to the greatest extent possible, but due to the complexity, number, and seriousness of the issues involved, Appellant cannot adequately present them within the default 50-page limit.
4. Appellant requests leave to file an amended brief not exceeding ****85 pages**** in total. This extension is necessary to preserve all meritorious claims and to support them with the factual and procedural specificity required for meaningful review.
5. Appellant is proceeding in good faith, and this request is made not for delay, but in the interest of justice. No party will be prejudiced by the requested number of pages.

WHEREFORE, Appellant respectfully requests that this Court grant leave to exceed the 50-page limit and permit the filing of an amended initial brief not exceeding 85 pages.
