Dear Mr. Maring,

Please accept my apologies for taking so long to respond to your transcript request.

I have reviewed my records and estimate your work will be 20 pages. Based on the current rate of \$3.25 per page, the cost will be \$65.00.

Under our rules, I have 60 days in which to complete the work. Upon receipt of a check from your law firm, the 60 days begin.
