MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Alan G. Nix respectfully requests a **fourth and final thirty (30) day extension from August 15, 2025 until September 15, 2025**, in which to serve and file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today.

2. Counsel for Alan G. Nix respectfully submits that extraordinary circumstances

exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Counsel will file the Initial Brief of Appellant and Designation of Matter in the case of The State v. Michael Valdario with this Court today, August 15, 2025. Counsel filed the Return to Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Tirik Jaquan Johnson-Epps with the Supreme Court on August 7, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Jason C. Palmer with this Court on July 30, 2025. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Ariel Robinson with the Supreme Court on July 28, 2025. Counsel filed the Return to Petition for Writ of Certiorari the Court of Appeals in the case of The State v. Samir Kevin Shank with the Supreme Court on July 25, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Devonte Anderson v. The State with the Supreme Court on July 18, 2025. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Bouvia Sales v. The State with the Supreme Court on July 18, 2025. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. James Curry with this Court on July 7, 2025. Counsel filed the Initial Reply Brief of Appellant in the case of The State v. Rico Funderburk with this Court on June 26, 2025. Counsel filed the Petition for Rehearing in the case of The State v. Terry S. Tyler with this Court on June 26, 2025.



requested.


