
PETITION TO SUBMIT
AMENDED RECORD ON APPEAL

Pursuant to Rule 240, SCACR, the undersigned counsel respectfully petitions for leave to submit an Amended Record on Appeal filed in the above titled case on appeal. In support of this petition, counsel presents the following facts.

1. The Record on Appeal was filed with this Court on August 6, 2025.
2. In preparing Appellant's final brief, counsel noted the designation of matter contained a typographical error. The original designation noted pages 711-912 of the trial transcript but the intended page designation was for pages 711-917. The five (5) omitted pages are the conclusion of the argument raised by Appellant's first question presented to the Court. In an effort to resolve the oversight before final briefs were filed, counsel for appellant contacted counsel for respondent on August 14, 2025, about the error and the

need to file an amended Record on Appeal. Counsel for Respondent has now filed respondent's final brief in reliance on the existing Record on Appeal but has also graciously agreed to the filing of the amended Record on Appeal. In order to avoid conflicts with the record cites contained in Respondent's final brief, Appellant has added the omitted pages at the end of the Record on Appeal. Though out of order, this will avoid requiring an amended final brief from Respondent.


