**MOTION TO REQUEST A DATE OUTSIDE OF THE FILING DEADLINE FOR THE
INITIAL BRIEF TO BE EXTENDED THIRTY DAYS**

In accordance with Rule 207 of the South Carolina Appellate Court Rules (SCACR), the Appellant respectfully requests a 30-day extension beyond the current filing deadline of August 8, 2025. The extension is necessary to allow the Appellant, a pro se litigant, additional time to obtain essential documents from the Magistrate Court, specifically the transcript for Case No. 2024CV4610300028, dated January 22, 2024.

On August 7, 2025, the Appellant attempted to request the transcript in person but was denied access to the Magistrate Court. At the security checkpoint, the constable on duty refused entry and declined to provide his name. This is part of an ongoing pattern of difficulty in obtaining the transcript. On a previous attempt, a court supervisor stated that the transcript would cost \$25. Three days later, the Appellant was informed that the transcript was no longer available in the system. Given these challenges, additional time is essential to secure the necessary documentation to properly prepare the appeal.


