MOTION FOR EXTENSION

Pursuant to Rules 240 and 263(b), SCACR, Appellant George Simpson respectfully requests an extension of the deadlines to file and serve the initial brief of appellant and designation of matter to be included in the record on appeal. The current deadline is August 25, 2025. This Court reinstated this appeal on June 20, 2025 and subsequently set the briefing schedule. Respondent Sherman Green subsequently moved the Court for clarification of its order with a request that the parties brief appealability.
