
On June 4, 2025, Appellants filed a Record on Appeal and the Respondent filed an objection to the Record on Appeal as the Appellants failed to include all of the items listed in the Respondent's Designation of Matter. On August 6, 2025, this Court issued its Order striking the June 4, 2025 record on appeal and ordered the Appellants to amend the record on appeal to comply with Rule 210(c), SCACR. The Order further provided details to the Appellants as to how the record on appeal should be arranged. On August 18, 2025, the Appellants filed their Amended Record on Appeal.

Appellants' Amended Record on Appeal still suffers from the same defect as the previous Record on Appeal – the record does not include all matter designated to be included by the Respondent under Rule 209, SCACR. The Appellants have failed to include any of the Respondents' exhibits to any of its pleadings filed in the trial court and designated to be included by the Respondent. The pleading includes any of the exhibits referenced in the pleading and attached to that pleading.

Rule 210(c) provides that the Record on Appeal should include all matter designated to be included by any party under Rule 2009 and shall comply with the requirements of Rule 267. A review of the Appellants' Record of Appeal reveals that it fails to comply with these requirements. It is not possible for the Respondent to reasonably complete a final brief with an incomplete Record on Appeal. This is the second time the Respondent has had to file a pleading in this appeal because the Appellants have failed to follow the rules of this Court. The Respondent has had to incur significant time delay and additional attorney fees and costs on this case as a result of the Appellants' failure to follow the rules. For these reasons, the Respondent requests that the Appellants appeal be dismissed. If the Court decides that the appeal should not

be dismissed, the Appellants should be required to file a corrected Record on Appeal which adheres to the requirements of the South Carolina Appellate Court Rules.


