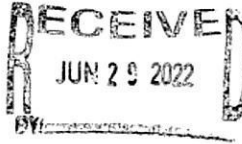

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on June 29, 2022 at approximately 3:36 AM, while at 3615 Dorchester Road (Mobile 1) which is located in the City of North Charleston, County of Charleston, State of South Carolina, the defendant, one **Javeon Breon Kayshard Campbell**, did, knowingly, unlawfully, and with malice aforethought, commit the offense of **MURDER** in violation of 16-3-10 of the South Carolina Code of Laws 1976 as amended. In that the defendant did shoot and kill the victim, Charrod Antonio Phillips while armed with a firearm.

Facts to establish the aforesaid are that on June 29, 2022 at approximately 3:37 AM officers with the North Charleston Police Department were dispatched to a shooting at the Mobile 1, located at 3615 Dorchester Road. Upon arrival, officers located the victim inside the store suffering from gunshot wounds. Charleston County EMS responded and pronounced the victim deceased. Surveillance footage from the store was reviewed which showed the victim enter the store at approximately 3:35 AM and proceed to the register to make a purchase. At approximately 3:36 AM a blue sports utility vehicle pull into the parking lot of the store and a suspect appears to exit the left rear seat and enter the store. When the suspect enters the store he is seen pulling a pistol from his front right pants pocket and shooting the victim in the back several times before fleeing back to the vehicle. The suspect vehicle is seen fleeing east on Dorchester Road. During further review of the surveillance footage it appeared that the suspect had a ankle monitor affixed to his right ankle. Detectives forwarded a still shot of the suspect from the surveillance footage to Charleston County Department of Juvenile Justice who provided a name of Javeon Breon Kayshard Campbell as possibly being the suspect. They further confirmed that he was being monitored via an ankle monitor, however the monitor had been disabled due to a dead battery. Previous booking photographs of Javeon Breon Kayshard Campbell were compared to still shots of the suspect from the surveillance footage and confirmed to be one in the same.

All based on the investigation of Detective Pritchard and statements provided by the witness who is witness to prove the same. All this done against the law, peace and dignity of the City of North Charleston and the State of South Carolina.



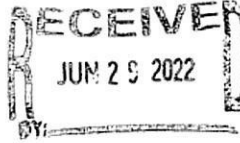
