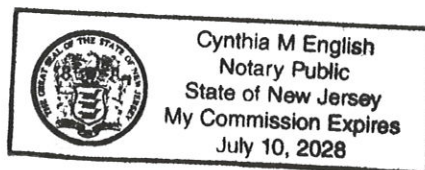

FINAL JUDGMENT AND DECREE IN EQUITY

COURT OF RECORD:

Let the record show:

1. Claimant, Jameerah Tahidah; Ware©, has duly filed and served Her Verified True Bill in Equity.
2. Respondents have been given full and fair opportunity to answer, rebut, or otherwise contest the claims therein.
3. Respondents have wholly failed to respond, rebut, or defend within the time prescribed, and are therefore in default.
4. The record contains conclusive evidence of such default, including:
 - **A Certification of Non-Response by Notary Cynthia M. English©**, verifying non-response.
 - **A Certificate of Non-Response/Judgment By Confession by Secured Party Jameerah Tahidah; Ware© and King Lord Noble, R Asanti, Ali©**, verifying, certifying, and affirming Respondents’ refusal or failure to respond.
 - **An Affidavit for Entry of Default and Final Judgment by King Lord Noble, R Asanti, Ali©**, sworn, un rebutted, and entered as judgment in commerce.
5. In equity, an un rebutted affidavit stands as truth, and truth, un rebutted, is final judgment.

DECREE

Accordingly, under the authority vested in “We The People” by The Constitution for The United States Republic (1791) and the Law of Equity, it is hereby declared, ordered, adjudged and decreed, that:

1. The relief demanded in the True Bill is **GRANTED**, and all equitable remedies therein are **ORDERED** and **ENFORCED**.
2. Respondents are in default, having admitted the claims by silence.

3. Default judgment is **ENTERED** against Defendant A AND K PROPERTIES OF SC INC.
4. Defendant lacks standing and “fail[ed] to state a claim upon which relief can be granted”.
5. All filings and pleadings of Defendant; and the judgment entered on August 21, 2025 4:41 PM and judgment entered on January 29, 2025 by the Court of Common Pleas, Horry County, South Carolina; and the proceedings, judgment of execution and writ of ejection entered on January 6, 2025, are declared irregular and **NULL** and **VOID** ab initio, without lawful force or effect, nunc pro tunc, and **VACATED** for lack of subject matter jurisdiction.
6. Respondents, their agents, successors, and assigns shall immediately, and in no event later than **three (3) days** from entry of this Order, comply with this Judgment, and vacate any claim against Plaintiff WARE TRUST© and its Secured Party Creditor.
7. Respondents are **PERMANENTLY ENJOINED** from instituting, prosecuting, or enforcing any eviction or possession action against Plaintiff concerning the subject property.
