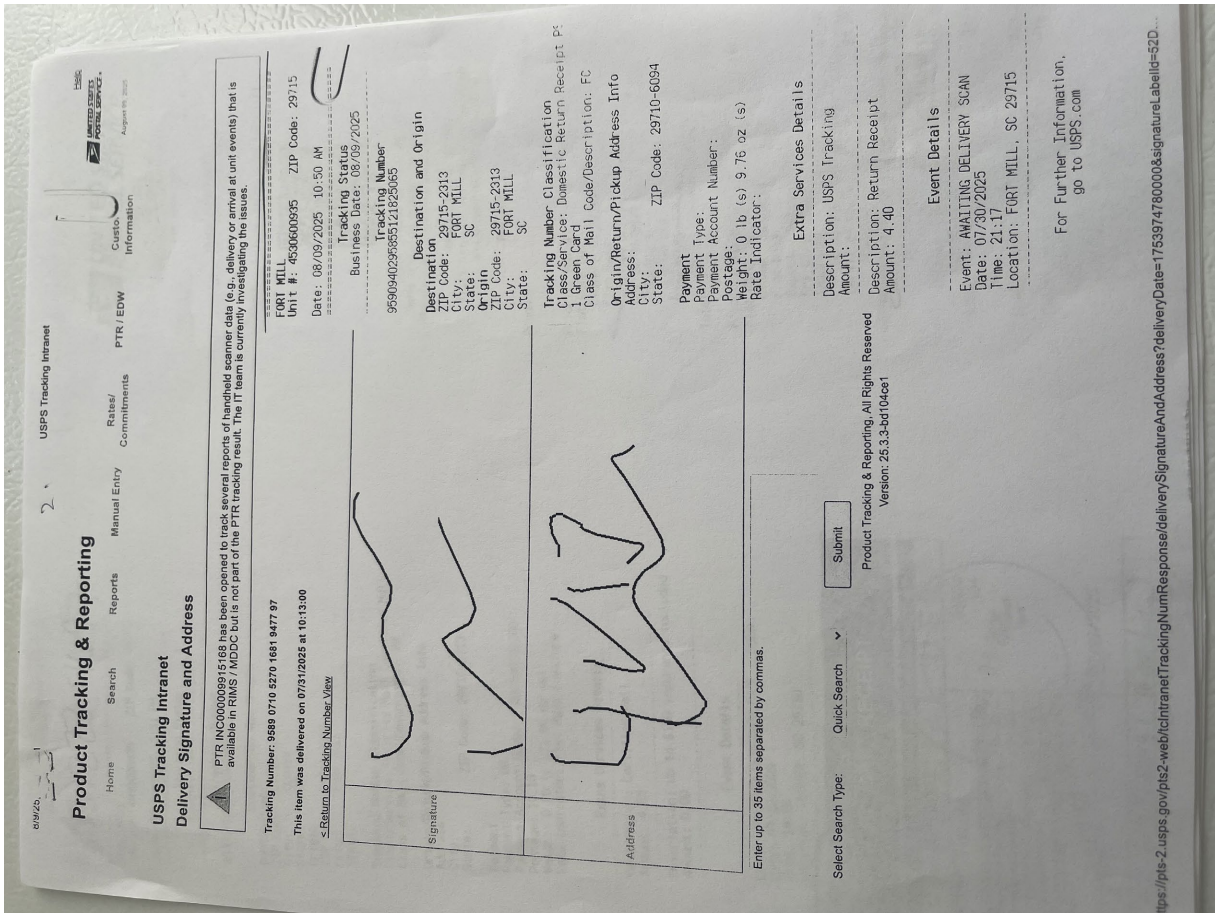
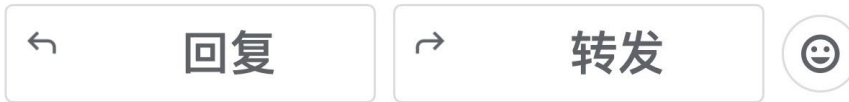

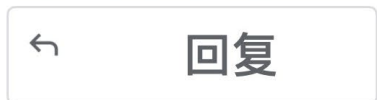

Dear Manager Nakisha,

It has been 10 days. Could you please update me on the investigation? I sent my certified mail to Cherry Restaurant, Suite 113, 4034 Charlotte Hwy, Clover, SC 29710. The restaurant is open 7 days a week.

Why was the mail signed and received by a neighbor instead of the actual addressee? The owner of Cherry Restaurant is Tony Lin (Lin Yi Tong), and the manager is also him. According to the rules, the addressee himself should show a government photo ID to sign for certified mail. The delivery carrier should know this requirement clearly.

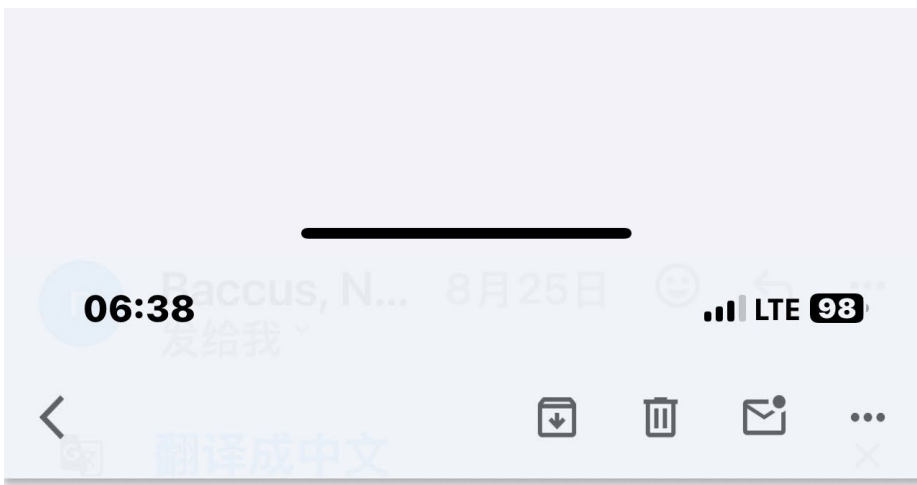

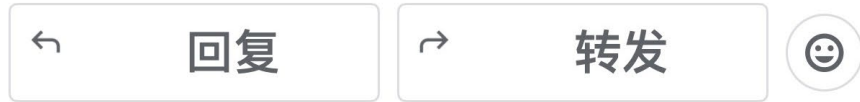
