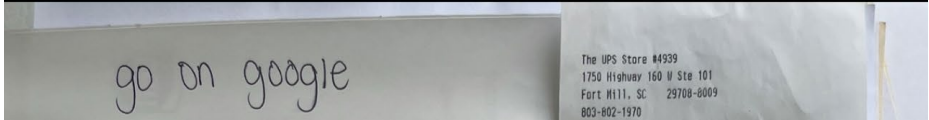

Delivery Attempts and Issues:

1. 06/23/25 – I personally attempted delivery to Cherry Sushi Bar, 4034 Charlotte Hwy, Ste 113, Clover SC 29710. The defendant Tony refused to accept and threatened to call the police.
2. 06/24/25 – Sent through UPS (1750 High Way, Fort Mill SC 29708). I requested the "Certified Mail + Return Receipt" service, which she said was the same. She then scammed me and charged me \$19.66. There was no return receipt.
3. 07/02/25 Re-sent to new address without Ste 113, but mail was returned. USPS 201 Tom Hall ST charged \$19.05.
4. 07/09/25 – Resent at the same post office, but staff member James failed to enter the return receipt number, making it untraceable. Fee was \$19.05. Later, staff member Jen admitted the mistake and offered a free reshipment.
5. 07/29/25 – USPS reshipped, but no return receipt was provided.
6. 08/25/25 – USPS Clover branch (913 Bethel St) made another error. The Cherry restaurant operates seven

days a week, but the delivery was signed by a neighbor, and the two signatures were inconsistent. Later, Manager Nakisha admitted it was the carrier's mistake.

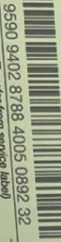

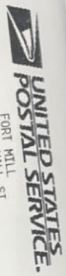

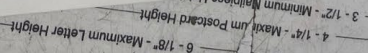
