**MOTION TO FILE EXTENSION REQUEST OUT OF TIME AND  
MOTION FOR FIRST EXTENSION OF TIME**

The Initial Brief of Respondent and Designation of Matter were due to be served and filed on August 27, 2025. Due to a calendaring error, the Respondent mistakenly did not timely file a Motion for First Extension of Time. As a result of the calendaring error, the Respondent respectfully moves this Court to relax the requirements of Rule 242(f), SCACR, and permit the State to file a motion for a first extension of time. See Rule 263(b), SCACR (“The time prescribed by these Rules for performing any act except the time for serving the notice of appeal under Rule 203 and 243 may be extended or shortened by the appellate court, or by any judge or justice thereof.”). The undersigned counsel apologizes for any inconvenience this request has caused to the Court and to the Petitioner and does not believe this request will result in any prejudice to the Petitioner should it be granted.

Additionally, Respondent moves this Court for a thirty-day extension of time within which to file and serve the Initial Brief of Respondent. This is the Respondent's first request for an extension in this matter. This extension is not intended for purposes of delay but is necessitated by a heavy workload and recent staffing turnover within the South Carolina Department of Education. The Respondent therefore asks this Court to accept its motion for an extension of time out of time and to grant an extension of time within which to serve and file the Initial Brief of Respondent and Designation of Matter.

**WHEREFORE**, Respondent prays that the Court relax the requirements of Rule 242(f), SCACR; accept the filing of the Motion for First Extension of Time Within Which to Serve and File the Initial Brief of Respondent and Designation of Matter out of time; extend the deadline for the service and filing of the Initial Brief of Respondent and Designation of Matter in this case for thirty (30) days from the date such relief is granted; and for such other and further relief as the Court may deem just and proper.
