At a Court of General Sessions, convened July 2024, the Grand Jurors of Berkeley County present upon their oath:

**Children / Unlawfully place a child at risk of or cause harm or willfully abandon the child**

That in Berkeley County, South Carolina, on or about on or about June 1, 2024, the Defendant, April Jarqvavia Lilliston, while having charge or custody, or being the parent or guardian, or being responsible for the welfare of the minor child, Donneria Lilliston, did (1) unlawfully place the minor victim at unreasonable risk of harm affecting the child's life, physical or mental health or safety; or (2) unlawfully and maliciously do, or cause to be done, bodily harm to the child so that the life or the health of the child was endangered or likely to be endangered; or (3) willfully abandon the child. This is in violation of Section 63-5-70 of the South Carolina Code of Laws (1976) as amended.


