On various occasions between 2014 and 2017, the defendant, James Ehridge Jones Jr, did willfully and unlawfully commit the offense of Criminal Sexual Conduct with a Minor 2nd Degree in violation of South Carolina code of laws 16-03-0656. The defendant fondled the breasts and vagina, on top of and under the victim's clothing, on several occasions while the victim was between eleven and fourteen years of age. The victim disclosed the incidents during a forensic interview with Hopeful Horizons. The incidents occurred in the town of Bluffton, Beaufort County, South Carolina.
