I am going to be filing an appeal on this order for the following reasons: I did amend schedules B/F , Statement of Financial Affairs along with updated Creditors per the Trustee telling me to do, on August 24, 2025 prior to the order on August 29, 2025 .

2) On page 4 how is it that no full payments were made during the entire lease but then it was stated no payments were made from November 2024 to August 2025 so which one is it.

3) I never said that the stay should be extended because I had personal issues with Morgan R Dunn the Attorney, I said I had personal issues with her and had contacted the Bar Association about her, that's what I said.

4) I asked for at that time I had filed a Chapter 13 and had requested for the court to convert it over to a Chapter 7 and if they couldn't and the case had to be dismissed could it be without prejudice so I could file Chapter 7 and it was granted so no there isn't any abuse going on in this case the law allowed for me to do it and that's what I did.

5) On page 5 I need for the judge to prove that what I said after the hearing was over was directed to her. I was in my house and was on zoom for my hearing due to a knee injury and could attend hearing in person. I had people in my house so I can say what I want to. Maybe she should've listened a little longer on the phone. After the hearing was over she would've heard the other person that I was talking with was about someone else so that's what she gets for ear hustling too hard.

6) Why would I dispute a lease that I had signed.

7) How can I sign a lease on March 18, 2024 to rent from March 21, 2024 to June 20, 2025 the lease starts when you sign it.

8) There has always been discrepancies since last year on the ledger and when I tried to address the issue with the Magistrate Court judge Christopher Arakas he didn't want to address the issue.

9) A full payment was made in August 2024 where I had to pay most of the rent for a Agency called Helping Hands here in Myrtle Beach to help with \$400 and those payments are on the ledger. If I hadn't made any payments from the time I moved in I would've been in way before November 2024.
