I, John Dial Jr., petition the Court
for writ of certiorari for the following
reasons:

1.) On 6-18-25 I was unconstitutionally
convicted of DV 1st in the 5th Judicial Court,
Case # 2025GS4000108. In which I did not have
a fair and impartial jury that the Constitution
affords me. On that jury sat Dr. Mark Robinson
a doctor that I was sent to previously from
jail because of an assault that occurred. I
currently have a suit against him for medical
malpractice (Case # 0:25-CV-10432-MGL-PSG). When Dr.
Mark Robinson came up for jury selection I
immediately told public defender, Eric Fox, that
I knew him and how rude he treated me
in his office and that he didn't hide his
contempt for someone facing criminal charges.
Fox did nothing. After repeated attempts

him to do something, I had to tell Judge Kimpson myself. Even after telling the judge, he even allowed it. I also have a suit on that issue as well filed. ②

2.) Eric Fox did nothing to advocate for me during trial. All the evidence he showed me in county jail that he was going to use, then he did not present nothing. The prosecution presented a picture of smeared lipstick and a deputy testified it was blood. Later I found out this deputy was coached to lie by prosecutor N. Fowler. This got back to me because my brother is a Richland County Deputy and other deputies did not think it was right. None are willing to come forward for fear of retaliation and I can't disclose anything because I would no longer receive information. Fox also denied me a medical expert and also allowed N. Fowler to withhold a police body cam of alleged victim with no injuries with a red substance on her leg that clearly wasn't blood. It was staged just like smeared lipstick. This was exculpatory evidence that anyone can see for what it was.

I have made complaints against all parties ² with The Office of Judicial Conduct.

3.) Nick Fowler lied to Judge Kimpson during Sentencing. After Fowler read my record and it was my turn to speak Fowler then says "Your Honor, we found 5 more convictions of DV that was not on his SLED report, for a total of 7." That was perjury committed on record and was ~~intentionally~~ intentionally done to persuade an already biased judge to give me a harsher sentence. Also I gave Judge Kimpson a letter informing him that I had been an FBI informant and in placing me at SCDC places my life in danger. Without any research Fowler told judge that was a lie. Everything in that document can be verified as true. N. Fowler has lied at every court proceeding I've had to deceive the courts, there is no telling what has been done behind the scenes.

4.) At the time of trial I had asked for a writ of certiorari against Judge Kimpson because he had treated me unfair and felt wronged, this was before trial. It was a suit filed

against him and the 5th Circuit Solicitors office. I had also wrote him personally before trial and filed other motions. In the Suit I listed Judge Kipling by mistake, C/A No. 3:25-2617-MGL-PJG. (4)

WHEREFORE, John Dial moves the court for a writ of Certiorari and ask the court to reverse or vacate the judgement set against me of 9 years and/or any further relief as the court deems just and appropriate.
