**APPELLANT’S UNOPPOSED MOTION FOR EXTENSION
OF TIME TO ORDER TRANSCRIPTS**

Appellant Adams Outdoor Advertising Limited Partnership (“Appellant”), by and through its undersigned counsel, and with the consent of Respondent West and Joyce, LLC, successor in interest to West Oil Company (“Respondent”), respectfully moves this Court, pursuant to Rules 240 and 263, SCACR, for entry of an Order granting a 7-day extension of the time within which Appellant must order transcripts, such that the deadline would be extended to September 15, 2025. The grounds for this motion are as follows:

1. As the Notice of Appeal in this matter was served on August 28, 2025, the deadline to order transcripts, pursuant to Rule 207(a)(1), SCACR, is Monday, September 8, 2025.¹

2. Appellant's attorneys have had multiple professional commitments in the week leading up to the current deadline, including multiple substantive filing deadlines in other cases. In addition, undersigned counsel was recently retained for the Appellant and is still gathering information related to the proceedings in the lower court.

3. Accordingly, Appellant requests that this Court grant an extension of seven (7) days' time to order transcripts of the proceedings below.

4. This is Appellant's first request for an extension of said deadline.

5. This requested extension of seven days would place the new deadline on September 15, 2025.

6. This Motion is supported by the grounds set forth herein and the South Carolina Appellate Court Rules. Undersigned counsel conferred with counsel for Respondent prior to filing the instant motion, and Respondent consents to the extension of time requested in this motion

WHEREFORE, Appellant respectfully requests that this Court grant Appellant an additional ten days in which to order the necessary transcripts of proceedings below.
